- There will be one judge per **ORGANIZATION/ENTITY** performing in the show. Each judge will score all teams except their own organization.
- You can use props if you wish.
- Each team is required to make 1 step and 2 strolls.
- You can repeat the strolls but are not limited to.
- Each step should be a minimum of 6 min and a max of 9, and max of 2 dances in each step.
- Each stroll has to be a max of 2 min.
- Any formation is accepted.
- Each participating team is required to have 1 judge and 1 music person.
- Each step and stroll will be judged on Originality, Synchronization, Difficulty, and Hypheness.
- All teams will be able to show all steps and strolls. NO elimination rounds. Points will be added and winners will be chosen from an over all score.

Show Format:

The Step/Stroll show will consist of three rounds. All rounds will be performed; there will NOT be any elimination rounds. Each round will be individually judged on a point system, which will then be accumulated after the final round.

Round One: Step Round

- All teams will perform a step in round one.
- Each step should be a minimum of 6 min and a max of 9
- And max of 2 dances in each step.

Round Two and Three: Stroll Rounds

- Each stroll has to be a max of 2 min.
